## CANADIAN FORCES BASE BORDEN MOTORCYCLE CLUB WAIVER/RELEASE OF LIABILITY

I recognize and understand that by participating in sport and recreational activities organized and/or sponsored by the Canadian Forces Base Borden Motorcycle Club, my child could become injured or suffer adverse medical consequences in many different ways. I also understand that such risks include death and medical or physical disability.
2. Nevertheless, in consideration of the acceptance of my request to participate in the above-noted activities, I (on my own behalf and on behalf of my child) do hereby:
  - a. release and forever discharge the Canadian Forces Base Borden Motorcycle Club, its executive, instructors, sponsors, agents and members, as well as Her Majesty the Queen in Right of Canada, the Base Commander CFB Borden, all Canadian Forces Officers and Non-commissioned members, and all of Her Majesty's servants, agents and employees, from any and all claims for loss, injury or damage to persons or property and from all manner of actions, causes of action, suits, debts, dues, accounts, bonds, covenants, contracts, claims and demands whatsoever arising from, or contributed to by, my participation in Canadian Forces Base Borden Motorcycle Club activities, or arising from, or contributed to by, any travel to and/or from such activities; and
  - b. agree to indemnify and save harmless the Canadian Forces Base Borden Motorcycle Club, its executive, instructors, sponsors, agents and members, as well as Her Majesty the Queen in Right of Canada, the Base Commander CFB Borden, all Canadian Forces Officers and Non-commissioned members, and all of Her Majesty's servants, agents and employees, from all manner of actions, causes of action, suits, debts, dues, accounts, bonds, covenants, contracts, claims and demands whatsoever, related, either directly or indirectly, to any loss, injury or damage to persons or property arising from, or contributed to by, my child's participation in Canadian Forces Base Borden Motorcycle Club activities, or arising from, or contributed to by, any travel to and/or from such activities.

I further grant permission for the Canadian Forces Base Borden Motorcycle Club to use and/or publish, for promotional and/or informational purposes only, any photographs taken and/or audio/video recordings made during the course of the above-noted activities that contain my child's image or likeness.
4. This Waiver and Release shall be binding upon me and my child's heirs, executors, administrators and assigns.
