b. agree to indemnify and save harmless the Canadian Forces Base Borden Motorcycle Club, its executive, instructors, sponsors, agents and members, as well as Her Majesty the Queen in Right of Canada, the Base Commander CFB Borden, all Canadian Forces Officers and Non-commissioned members, and all of Her Majesty's servants, agents and employees, from all manner of actions, causes of action, suits, debts, dues, accounts, bonds, covenants, contracts, claims and demands whatsoever, related, either directly or indirectly, to any loss, injury or damage to persons or property arising from, or contributed to by, my participation in Canadian Forces Base Borden Motorcycle Club activities, or arising from, or contributed to by, any travel to and/or from such activities.

3. I further grant permission for the Canadian Forces Base Borden Motorcycle Club to use and/or publish, for promotional and/or informational purposes only, any photographs taken and/or audio/video recordings made during the course of the above-noted activities that contain my image or likeness.
